You can give your clients the opportunity to try the hearing instruments immediately after their hearing evaluation. As you review the audiogram results, you can be assured they can hear everything that is being shared. Now you're ready to offer them a personalised and risk-free start to their hearing care.

Programming hearing instruments for the trial period

Step 1: Detect the hearing instrument(s)



- Connect the hearing instrument(s) to Unitron TrueFit[™] fitting software using the compatible programming interface
- Click the Detect button
- The detection dialog will indicate when the hearing instrument(s) have been successfully detected

Step 3: Confirm or adjust the trial duration

- The default trial duration is ~4 weeks. Go to End Fitting > Beeps to modify the trial period
- You can also modify and demonstrate the beeps that your client will hear at the end of their trial period from this screen



Beep settings can be accessed by navigating to the End Fitting > Beeps screen

Unless there are special circumstances, leave the FLEX:TRIAL duration set to the default (~4 weeks) to prevent clients from hearing the end-of-trial beeps.

Step 2: Fit the hearing instrument(s)

- When FLEX:TRIAL devices are detected for the first time, or "new fitting" is selected, there is an additional step at the beginning of the First Fit workflow
- From this step you can select the desired technology level
- Click Next and follow the First Fit workflow as you normally would

Step 4: Save the fitting and start the trial period

• After saving the fitting, the hearing instrument(s) are ready for a real-world assessment

Step 5: Provide your client with counselling for a successful trial



- Print out or email the Getting Started Guide for your client – this guide acts as the User Guide for trial devices and includes all applicable regulatory information
- To customise your template, go to Options > Preferences > Email Templates

Access the Getting Started Guide by navigating to End Fitting > Fitting Summary
